1 Objective, Allow for 3rd party Comprehensive Audits of the Elections

What does this mean:

1. **Complete audit of the equipment and internet access.** *This is not about election workers doing something bad, but people from outside that can impact an election outcome without our knowledge.*
2. **Complete Audit of the systems used to process our ballots, including from the time that ballots are printed, through to their being processed for collection, counting and final storage.**
3. **Complete audit of the databases used to determine who is eligible to vote.** *Yes, every valid voter should be encouraged to vote, and their votes should be counted. No person that has a right to vote, should be restricted from voting.*

What is so wrong with Transparency?
